
SERVICE LEVEL AGREEMENT

BETWEEN

STRENGTH SECURITY LIMITED

AND

.....

STRENGTH SECURITY LIMITED a Company duly incorporated in Nigeria and having its registered office at Plot 1, Block 94, Providence Street, Lekki Phase 1, Lekki Lagos. (Hereinafter referred to as “the Company” which expression shall where the context admits include its successors in title and assign) of the other part.

AND

..... (Herein after referred to as “the Client” which expression shall, where the context to admits include its successors in title and assigns) of the other part.

WHEREAS:

- i “The Company” is a Security consultancy Company duly Incorporated under the Federal Republic of Nigeria and carries on the business of provision of security, escort services amongst other security services throughout the Federal Republic of Nigeria and is desirous to render security guards service to “the Client”.
- ii. “The Client” requires the services of a reputable security company for the security of its premises and goods and is willing to employ “the Company” for provision of security guards services for protection.

NOW IT IS HEREBY AGREED AS FOLLOWS:

1. “The Client” will employ “the Company” and “the Company” will serve “the Client” in the provision of security guards services from the commencement date indicated hereunder. Hereafter renewable from year to year in such terms to be mutually agreed upon by both parties until this contract is determined as hereinafter provided.
2. During the continuation of this agreement “the Client” will pay to “the company” a monthly charge of **Eighty Five Thousand Naira (N85,000.00)** per guard. Payable in full in arrears out of which the company to pay each guard **70% of the total amount whilst the company take the remaining 30%**
3. During the subsistence of this agreement, “the Company” shall endeavor through its well-trained guards to provide Twenty four (24) hours security service (Day & Night) at the price agreed above and the number of the personnel as contained in the Offer Letter.
4. The Company’s guards are not transferable from the location originally deployed without the prior consent in writing of “the Company”.

5. At the commencement of this agreement, “the Client” shall, in conjunction with “the Company” take complete inventory of the goods and / or equipment available at the premises to be secured.
 6. “The Company” and “the Client” hereby mutually acknowledge the fact that the Company’s guards by law are not allowed to carry ammunition; however, “the Company” agrees with “the Client” that in the event of an Armed robbery attack, its guards shall take reasonable steps to alert the police and will assist the police in whatever way possible to foil the robbery.
 7. “The Company” hereby agrees with “the Client” that it shall accept liability for theft of any property in “the Client’s premises arising out of and directly attributable to negligence, conspiracy and/ or connivance of its guards during subsistence of this agreement.
 8. Either party may at any time terminate this agreement by giving to the other one calendar month notice in writing or by payment in lieu of notice.
 9. In order to avoid a possible clash of interest during the subsistence of this agreement, “the Client” shall not engage the services of any other security company to cover the same location where “the Company” currently provides guards services.
 10. During the continuation of this agreement “the Company” shall conduct themselves honestly and properly in the course of their duty towards “the Client” and “the Client’s customers and also towards all other persons who may through the permission of “the Client” have access to the premises.
 11. Not divulge or disclose to any person or persons whomsoever any secret entrusted to it or its guards or coming to its knowledge in the course of its retainer-ship or otherwise or of their customers or other which ought not to be disclosed or made public.
 12. In case of any dispute arising out of agreement, the same shall be subject to the laws of the Federal Republic of Nigeria.
