#### BETWEEN

Uplift Medical Property Management Limited a company duly registered under the Companies and Allied Matters Act (CAMA) in Nigeria with its address at No 15A Admiralty Way, Lekki Phase 1 Lagos State (hereinafter referred to as "Uplift Med" and which expression shall, where the context so admit includes it assigns, personal and legal reprehensive of the ONE PART.

#### AND

**S.E Ogebe, ESQ** (practicing with D A Awosik lp under the name and style of The Ogebe Defence Chambers (a firm of barristers, solicitors property managers and legal consultants), having its office at 29b Dr. Ezekuse Close Off Admiralty Way Lekki Phase 1 Lagos (hereinafter referred to as "**Solicitor**") of the OTHER PART.

WHEREAS IT IS AGREED AS FOLLOWS

Uplift Med hereby retained the Solicitor in the following legal matter to wit:

- 1. To take over the case with Suit No: MCL/721/19 or MCL/722/19 Stallion Technologies Limited V. Mr. George Kenneth Kalunta both or whichever of this that is pending at the magistrate Court of Lagos Station and defend Stallion Technologies in the best professional way possible and if necessary discontinue the above listed cases or any of it and institute and prosecute fresh one at the most appropriate court in the best interest of Uplift Med.
- 2. The **Solicitor** shall to the utmost of his ability and skill employ all diligence to, in handling the above listed case
- 3. The employment of the Solicitor in relating to the matter specified hereto shall be terminated at anytime the magistrate court wherein the matter is instituted delivers it final judgment or decision in the matter
- 4. In the event that it become necessary for the Solicitor to Appeal the decision of the magistrate Court in the above listed case or to defend or respond to an Appeal as the case may be, Uplift Med and the Solicitor shall draw a new contract which shall reflect the details of the Appeal and the terms of the contract to Appeal.
- 5. sUplift Med shall pay the **Solicitor** the sum of One Million Six Hundred Thousand Naira only (N1,600,000.00) for taking over, prosecuting and or instituting new action for recovering of the premises contained in clause one and two of this contract.
- Uplift Med shall make all details and document relevant for prosecuting and defending above referred case available for the Solicitor and shall not do anything to frustrate the Solicitor from recovering the premises here above referred
- 7. Uplift Med shall not terminate this contract while an action is already pending in Court unless it is manifesting obvious that the Solicitor is not capable of handling the case.
- 8. The Solicitor shall not withdraw his services and legal representation in respect of the above referred case until Judgment is delivered at the magistrate Court
- 9. Upon the execution of this contract and the payment of N1,000,000.00 (one Million Naira only) Uplift Med shall immediately commence the performance of the recovery of the premises contained in this contract
- 10. The solicitor shall employ all professional mean whether specified here above or not to prosecute the recovery of premises case here above referred
- 11. The Solicitor shall accept two installments payment of N1,000,000.00 which will be divide into two parts, N500,000 upon execution of this contract before the commencement of work, with the second N500,000.00 in 4 weeks' time and N600,000.000 until judgement has been passed on the recovery of premises case.
