the purpose of performing sales, marketing, and related support services for the

Corporation’s online products and services, including but not limited to:

System, and any additional IT or innovative products as may be designated by the

Corporation from time to time.

- D. Employer Support Services Module
- E. Other Advance Client IT Designed Products
- F. Health Facilities and Users
- G. Purchase and Renting of Properties
- H. E-commerce Market Place

## 1. COMPENSATION AND RELATED TERMS

1. Commission Rate: The Corporation shall be entitled to 12% commission on every client, lead, or business opportunity provided by the Corporation to the Agent/Agency that results in a completed sale or contract.
2. Duty oversight shall be provided by an assigned manager from the Corporation's USA office or designated local office.
3. The Agent/Agency shall receive certified training provided by Stallion Technologies Ltd as required.
4. The Agent/Agency shall maintain a functional PC work environment with reliable internet service and a smartphone capable of audio and visual communication.
5. Work may be performed remotely from the Agent/Agency's home or office location. If the Agent/Agency records no completed sales from Corporation-provided clients for a consecutive period of ninety (90) days, the Corporation may require participation in designated sales and marketing retraining or a performance review meeting.

## 2. AGENT AND AGENCY OBLIGATION

- 2.1 The Agent/Agency shall complete all required Stallion Technologies Ltd sales and marketing training

and onboarding and being certified as having completed the required programs.

- 2.2 The Agent/Agency shall provide professional sales, marketing, customer engagement, and service delivery to clients assigned or referred by the

Corporation and shall work toward meeting the Corporation's performance expectations.

- 2.3 The Agent/Agency shall attend all scheduled sales and marketing training, reviews,

seminars, corporate presentations, and regional events upon reasonable advance notice.

2.4 The Agent/Agency shall at all times maintain professional and ethical standards

consistent with applicable laws and regulations and shall conduct business with integrity, competence, and professionalism as required by the Corporation.

### 3. CONTRACT TERMS

#### 3.1 Termination for Cause

If the Agent/Agency fails to perform any obligation under this Agreement, the Corporation reserves the

right to terminate this Agreement in accordance with its terms.

#### 3.2 Voluntary Inactive Status

Either party may request a temporary or indefinite inactive status of this Agreement for cause. Any

request by the Agent/Agency shall be subject to written approval by the Corporation and shall specify

whether commission payments shall continue or be suspended during such period.

#### 3.3 Effect of Termination

This Agreement shall remain in effect until the termination date. Upon termination, all rights and

obligations of both parties shall cease, except for any commissions earned prior to termination.

#### 3.4 Severability

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall

remain in full force and effect.

#### 3.5 Governing Law

This Agreement shall be governed and construed in accordance with the laws of the State of Virginia,

USA, and applicable federal regulations, or any jurisdiction designated by Stallion Technologies Ltd as its

responsible headquarters for Agent/Firm services.
