**Letter of Partnership by United Christian Health Foundation USA and The Presbyterian Church of Nigeria for Mayo Dankeli Settlement of Dietera District, Song LGA of Adamawa State of Nigeria**

Greetings to you and congratulations on our first successful joint mission outreach service conducted on January 7th through the 10th, 2025 to the Fulani Community of Mayo Dankeli settlement of Dietera District of Song LGA in Adamawa State of Nigeria. Sequel to the Memorandum of Understanding between our highly esteemed organizations, we are delighted to embark on this project by God's special grace with you to bring the love and care of Christ to this Mayo Dankeli and as many other communities that the grace of God will guide and lead us to go and share His riches with care to all such local communities.

As working partners on this first project we are committed to the Memorandum of Understanding signed and witnessed with the Mayo Dankeli Community leaders and the local government officials, and hence we are now eager to proceed to the working phases as we await the final commitment and right hand of partnership by the Song Local government and the Adamawa state government as we also submitted to them in our request to the government officials of Adamawa State.



To this effect, we hereby want to request and define our partnership in this endeavor of such august development as granted to us by the document signed with the community, to spell out the duties, functions and practical areas of responsibilities by either parties of our partnership with you as to assure a smooth transparent and effective management of each module and aspect of our joint development agreed with the Mayo Dankeli Community.

1. United Christian Health Foundation will commit entirely at the outset in developing the recreational facilities of the development area and obtain one quarter to one third of allocated lands for the initial community recreational project developments. The Presbyterian Church of Nigeria will handle the development of the Nursery, Primary, Secondary and other schools, as well as the hospital project with two third to three quarters of the allocated lands.

2. The Presbyterian Church will handle the development and management of all schools in its entirety.

3. The Presbyterian Church will handle the development and management of the hospital facility, while UCHF commits only to partner in the health care facilities as a consultant partner in areas medical equipment supply and support, provide IT electronic medical record, Medical specialty support in different specialties of medicine, medical missions to the facility. All management and facility organization will be handled completely by the Presbyterian Church of Nigeria.

4. The Portable Water Projects will be developed separately by the Presbyterian Church for the Schools and hospital along with the power service to support such operations. While United Christian Health Foundation will provide and develop its own water facility with the necessary power generation system to handle the recreational facilities. The two parties may obtain assistance to jointly share power development and even in conjunction with the local government authorities in areas of power development, road access development and maintenance as well as other services deemed needful for the progress and development of the communities. The recreational facilities would include a retreat event facility, an accommodation hotel, Restaurant for food and a Game nature preserve program with facilities to serve and enhance visitors to the community.

5. Both parties pledge to work together as we are servants of Christ in this mission of the love of Christ. Nothing in this letter of work assignments of our partnership limits future development in expansion of each partner in the communities of this Mayo Dankeli settlement, or other parts of the local government or the state of Adamawa to extend, increase or adjust the services as the individual partners deemed fit to improve or manage in their involvement in the development of the region.
