## STALLION TECHNOLOGIES LLC SERVICES AGREEMENT

**THIS AGREEMENT**, made this 5th day of September 2024, effective on the 12th day of September, 2024 between Mr. Nihal Patel [hereinafter referred to as “**IT Programmer Provider**”] as an Independent Contractor, and **Stallion Technologies LLC** [hereinafter referred to as “**Corporation**”] a Virginia USA HQ IT Innovative Design Company with online IT development products.

- I. WHEREAS**, the IT Programming Provider agrees to provide services in programming development services which includes our online Questcts, Customer Encounter and Business Accounting Management Systems, Medicruz Electronic Medical Records System (EMR), AdvanceQT online Professional and Business support System as well as other online operational services. The corporation may opt to offer one or a combination of any of these services, which would be here specified.

**1. IT Products**

- A. Questcts.com – Customer Encounter and Business online Accounting Products
- B. AdvanceQT.com Professional Business and Users online Products
- C. Medicruz.com - HMS/EMR System and Medical Billing Services
- D. Ipropstore.com – E-Commerce Online Business product sales platform
- E. Other Advance Client Online IT Designed Products

2. Organization offers programmer the development of a Questcts.com and Medicruz.com identical App on a Microsoft dot net platform for desktop, interface for MAC, IOS I-Phone and Android phone Apps that will access the Log in page, automatically provide for an APP desktop link access for continuous access use to the Questcts.com and Medicruz.com. Upon initial activation of the App, it will automatically provide an APP icon to the user’s desk top, Microsoft windows, MAC, IOS and Android versions of phones. *Rajesh Kumar*

## **II. COMPENSATION AND RELATED TERMS**

### **1. Compensation.**

For completion of the above items of all product design parts by Programming, the Corporation shall pay the sum total of \$3,746.75 amount for the entire 3 parts programming services for Microsoft Windows, MAC, IPS Phones, Android Phones versions and deployed and design and upload of the 2 software product in Play store and App Stores which is due to be completed in 20 – 30 days from the signing date of the contract. An advance payment of up to 30% may be issued to programmers upon request and time from commencement of work of each part of each part until day 10th. At completion and delivery of service designed each product to organization successfully on the functional location of each part, programmer will be due additional 40% of the assignment contracted amount of one or more of each part completed. Upon testing and correction of all glitches and computer programming trouble items as revealed from live use testing for 2 – 4 weeks, the balance 30% of services may then be released for one and all of the sections. Note all payments are issued through QTpaid.com electronic transfer payment, which is subject to a required 7% processing fee on each payment. Total fees as follows

Product Part 3 – Deployment of \$1746.75 - Build, Prepare, Sign and Deploy for these Apps for Questcts and Medicruz for Playstore, App Store and designated App sites.  
Total = \$3746.75.  
7% platform fees at \$421.75.  
Net Payment - \$3325  
Advance pay of 30% at initial show and request of design performance of each product part  
40% on completion of each part  
30% of total cost as due to the client upon completion and designated testing period.

**5.1 Severability.** In the event any portion of this Agreement is found to be void, illegal or unenforceable, the validity or enforceability of any other portion shall not be affected

**5.2 Governing Law.** This Agreement shall be governed by and construed in accordance with the applicable federal laws and regulations and the laws of the State of Virginia.
