Dr. Rudberg earned his Doctor of Medicine from the Medical College of Wisconsin, where he was elected into AOA, a national honors society. Dr. Rudberg then completed his training in Internal Medicine at Boston University Medical Center. Dr. Rudberg is an international lecturer on the ethical and clinical challenges facing both families and physicians. He has presented a paper to the United States Senate on ways to improve care of older persons. He has been a member of several national working groups such as the Ethics Committee of the American Medical Directors Association, and Mentoring Group of the Society of General Internal Medicine.

Since June 1998, Dr. Rudberg has been on staff at Northwestern Medicine Lake Forest Hospital. He presently in his solo private practice. There, he devotes his time to caring for his patients in a variety of settings including hospital, clinic, nursing home and home care. Through his affiliations there, he was asked to serve on Congressman Mark Kirk's Healthcare Task Force Advisory Board, and again on a similar board when Kirk became a Senator in 2010. Among his many interests, Dr. Rudberg is an avid cyclist, swimmer and traveler.
