

regards to the medical equipment being funded. Documents not adequate for funding proposals are assigned back to the correct party, with a list of the required corrections to be made.

- Advanced use of Adobe Acrobat, specifically PDF creation, to generate the required medical documentation to gain funding for medical equipment.
- Proofreading of Texas Title XIX forms to ensure coding, HcPc codes, coding modifiers, and physician NPI and TPI numbers are correct.
- Troubleshoot computer hardware problems, telephone, internet, and networking issues for the office.
- Review and verify ICD-10 codes, HxPx codes, diagnosis codes, physician chart notes, and medical terminology in regards to durable medical equipment funding.
- Insurance verification in regards to Medicare and Medicaid.
- Correspond with customer care coordinators to insure all required medical documentation is present in the Venu database, and adequate for funding.
- Correspond with the prior authorization team to insure all documentation is adequate, correct, and sufficiently signed by the correct physician.
- Verify client's insurance, to insure it is correct, current, and adequate for funding of their medical equipment needs.
